### **Specifications**

- 1. All instruments should be of international quality & and made from surgical-grade stainless steel with carbon bonding on them.
- 2. All instruments should preferably have Tungsten Carbide Inserts / Carbon Inserts in the Jaws.
- 3. The Instruments must be vacuum hardened in order to receive the necessary hardness, tenacity, and corrosion resistance. Supporting test reports/certificates must be furnished.
- 4. The Instruments should have a certificate of Primary passivation process.
- 5. Every instrument has to be delivered with artificial passivation in the form of a chromium oxide layer to support the natural mutation of this layer from the beginning to make every instrument more corrosion resistant. This passivation process must be executed according to ASTM A967
- 6. The instrument steel should comply with EN ISO 7153 standard for stainless steel used for surgical instruments and ISO 13402 standards: Surgical hand instruments- determination of resistance against autoclaving, corrosion, and thermal exposure. The necessary certificate should be furnished.
- 7. The hinges should be rust-proof.
- 8. The instruments should be guaranteed against metal fatigue and rust.
- 9. The instrument's surface should be non-reflective.
- 10. The instruments should carry US FDA or European CE with a four-digit notified number.
- 11. The brand name, along with the catalog number, should be attached to the instruments.
- 12. The material used in scissors should be an alloy of Titanium & amp; / Stainless steel/ Tungsten carbide, resulting in superior corrosion resistance and precise cutting with durable cutting.
- 13. All instruments should have catalog numbers embossed on them.
- 14. The firm will have to demonstrate the instruments if required.
- 15. All instruments quoted should be from the same manufacturer with international quality standards with a maximum 5 % variation in sizes may be allowed.
- 16. All surgical Instruments should be from the same country of origin and from the same manufacturer.
- 17. All instruments and equipment must be of high-grade medical quality stainless steel, reflection-free (matte finish), lightweight, and user-friendly (both for application & comfortable use) unless otherwise specified, in anti-glare style finishing, if the used material and the construction of the instrument will allow it. The matting shouldn't be affected in an electro-plating process.

8. Surgical Instruments should have the following certifications:

- 19. Instruments should be supplied with 15 large-size Sterilisation containers for storage as well as for sterilization purposes; the same container should be autoclavable along with the instruments.
- 20. The sterilization containers should meet international standards and be approved for steam sterilization procedures to EN 285: 2008 and validated according to ISO17665.
- 21. The sterilization container lid is made of high-performance plastic- PPSU.
- 22. The sterilization container should be resistant to permanent deformation.
- 23. The sterilization container should be lightweight and scratch-proof.
- 24. The sterilization container bottom is made of high-quality aluminum.
- 25. The sterilization container should have carrying handles with a 90-degree arrester made of fiberglass reinforced PEEK that prevents the jamming of the hands with a 90-degree arrester.
- 26. The sterilization container handle should have low heat conductivity and heat storage properties (burning of hands)
- 27. The sterilization container should have a frontal accommodation field for labels and color tags.
- 28. The lid of the sterilization container should have a microbial barrier filter to resist the passage of microbes.

29. The microbial barrier filter should be reusable and easily accessible during manual and mechanical

30. The sterilization container lid should have a silicone lip gasket with a functional safety design, which provides a hygienically perfect smooth surface and no cavities for particles/ germs.

31. The locking system of the sterilization container should have a hinge-less opening button.

32. The sterilization container should have a red/ green indicator- during the sterilization cycle, the indicator turns to green, and as soon as the opening button is pushed, the indicator turns to red.

33. The surgical instruments and sterilization containers should be from the same manufacturer (no third-party product will be accepted)
