### SELECTION PROCESS:

- i. Online application form will be available at the Institute's website [www.aiimsjammu.edu.in](http://www.aiimsjammu.edu.in) under open jobs. Shortlisted candidates after scrutiny of application forms will be invited for interview on the date to be notified separately.
- ii. The applicant will be responsible for the authenticity of the information, other documents, and photographs submitted. If the candidate wants to apply for more than one post, a separate online application must be submitted for each post.
- iii. Mere possession of prescribed qualifications doesn't entitle a candidate to be called for interview.
- iv. If number of applications for each post exceed 10, then the candidates will be shortlisted. Shortlisting of candidates will be made based on past academic performance, research and public health experience.
- v. The candidates falling in the merit may be called in a ratio of 10:1 for the interview or as decided by the Competent Authority
- vi. Selection of the candidate will be based purely on the basis of marks obtained in the interview. In case of a tie in the final marks obtained, seniority on the basis of date of birth will be considered for selection.
- vii. AIIMS Jammu reserves the right to cancel/modify the recruitment process at any time, at its discretion. Only shortlisted candidates will be intimated for an interview by a call letter through email. Interviews will be conducted *in person* at the venue notified in the Interview call letter.

**SYLLABUS FOR ASSESSMENT:** The topics of assessment will focus on knowledge in relevant area of the project. In addition, the assessment will include quantitative and qualitative data management, analysis and reporting.

**PLACE OF POSTING:** Selected candidates are expected to work from AIIMS Vijaypur Jammu. However, the engaged staff is expected to do travel to AIIMS Delhi if required.

### TERMS AND CONDITIONS OF APPOINTMENT: -

1. The appointment will be purely on CONTRACT BASIS initially for a period of 12 months with effect from the date of joining, extendable up to the duration as mentioned above depending on the candidate's performance, project requirement and availability of fund. If the contract is not extended further, the same will lapse automatically after 12 months. The appointment can also be terminated at any time, on either side, by giving one month's notice or by paying one month's salary without assigning any reason. Candidates should note that their appointment will be for the Project only, and they will NOT be treated as regular employees of AIIMS Jammu for any purpose.
2. No other/ additional allowances other than the consolidated salary mentioned will be admissible. The appointee shall NOT be entitled to any of the benefits available to other employees of AIIMS Jammu appointed on a regular basis.
3. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.

4. The appointee shall not have any right or claim to an appointment, extension, or absorption in AIIMS Jammu on any post.
5. The appointee shall be on a whole-time appointment basis for the project concerned and shall not accept any other assignment paid or otherwise, and shall not engage himself/herself in private practice of any kind during the period of the contract.
6. No TA will be admissible for attending the interview and for joining the duties in case of selection.
7. Candidates employed in government job must produce a "No Objection Certificate" from their employer at the time of interview otherwise they may not be permitted to appear in the interview.
8. Leave entitlement of the appointee shall be governed as per ICMR guidelines.
9. If any declaration given or information furnished by him/her is found to be incorrect/ false or if he/she is found to have willfully suppressed any material or information, he/she will be liable for removal from service and also such other action as may be deemed necessary by the Competent Authority.
10. If any candidate is found canvassing for his/her selection, he/she will be disqualified from the selection process.
11. The final result will be declared on the website of AIIMS Jammu, and the selected candidate will be informed through email. Selected candidates may be required to join within 15 days.
