

- Advanced multipurpose table-mounted retractor system for Upper Abdominal -Lower Abdominal Gastrointestinal, Liver, Pancreatic and Biliary Surgeries.
- It Should have a bilateral frame to provide exceptional costal margin retraction and Stability.
- The Retractor should have a stabilization Retraction feature for long-duration Surgeries, maintaining rigid, firm and secure retraction for almost 10-12 hours.
- For retraction of the abdominal wall, solid and hollow viscera blades like Balfour, Richardson, Malleable, Harrington, Deaver, St. Marks, Kelly, and rest mentioned in Table 1, should be available in various detachable blade options in different configurations.
- The retractor should include a radiolucent St Marks blade.
- All blades should be detachable from the blade holder & different blades should be interchangeable with any/ all blade holders.
- The retractor should include the feature of a clip-on dual angling handle, which
 can help in easy tactile positioning and quick angling fine micro-adjustments,
 simultaneously ensuring retraction in the most complex surgical field.
- The Blade holder should have an inbuilt angling system on the blade holder.
- The blade & blade holder should have a fixed retraction feature to hold the organ.
 The blade holder and blades should lock precisely using the swivel and locking technology simultaneously.
- Blade holder rods should have a ratchet mechanism built for fine stepwise changes (1 to 1.5 mm) in the amount of retraction and finer adjustment.
- The blade holder system should have a pinch joint removal system for quick and easy handle removal.
- It should be of high-quality surgical stainless steel 410, 420 & US FDA/European CE/BIS approved and should be autoclavable
- Physical demonstration of the exact product quoted must be provided during technical approval.
- Two years warranty and GMC of five Years. by as per given by OEM
