All India Institute of Medical Sciences (AIIMS), Jammu, an Institute of National Importance, is one of the new AIIMS and apex healthcare Institute under the Pradhan Mantri Swasthya Suraksha Yojana (PMSSY) which has been established by the Ministry of Health and Family Welfare, Govt. of India, with the aim of correcting regional imbalance in quality tertiary level healthcare in the country, and attaining self-sufficiency in graduate, postgraduate and higher medical education and training.

Online applications from Indian citizens/persons registered as Overseas Citizen of India (OCI) cardholder under Section 7A of the Citizenship Act, 1955 as permissible under the applicable Act/Rules are invited for the following faculty posts on contract basis in various departments of All India Institute of Medical Sciences, Jammu.

GENERAL TERMS & CONDITIONS

1. The AIIMS, Vijaypur, Jammu reserves the rights to increase or decrease or not to fill up any post(s) without assigning any reason. The Competent Authority reserves the right to amend, cancel or change this advertisement as a whole or in part without assigning any reason or giving notice.
2. Applicants must possess the essential qualification and experience up-to-the last date of online submission of application(s). Their candidature will be cancelled at any stage if it is found that their educational qualification or experiences is/are not genuine.
3. **UPPER AGE LIMIT:** 50 years for Assistant Professor. For Professor (Consultant) as per Other Terms & Conditions given below.
4. **SELECTION PROCESS:** Selection is based on performance in the Interview. However, written test or screening, based on objective criteria may be done to short list applicants to be called for interview. The decision of the Competent Authority regarding shortlisting of candidates to be called for interview, would be final and binding on all candidates.
5. Canvassing of any kind will be a disqualification.
6. The candidate should not have been convicted by any Court of Law.
7. All disputes will be subject to jurisdiction of Court of Law at Jammu UT of J& K.
8. **APPLICATION FEE:** Rs 1000/- (Non-refundable)
9. **APPLICATION PROCESS:** The aspiring applicants satisfying the eligibility criteria in all respects can submit hard copy of application forms to Registrar, Academic Block, AIIMS, Vijaypur, Jammu on or before the last date as mentioned.
10. **ELIGIBILITY NORMS:**
 - a) The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling eligibility criteria as on the closing date of Online applications i.e. should have passed qualifying exam for essential education qualification / have completed duration of experience as given in Recruitment rules on or before last date of online submission of form. In those cases where one passes exam or complete duration of experience after this date, their candidature will stand cancelled.
 - b) Candidates must upload the documents/certificates in support of all the claims made by them in the application like, Date of Birth, Experience (in sequence as mentioned in application), Essential qualification(s), or any other information as applicable in their case, separately against each claim. Each document should be uploaded in PDF format. File size should not exceed the prescribed limit. Print out of all such file should be legible when printouts are taken. For this purpose, the applicant should scan the

documents/certificates in 200 dpi grey scale. Documents which have not been asked for like Pay Slip, Resume, Appointment letter, Relieving letter, Un-signed Experience Certificate etc. must not be uploaded in Document upload module.

- c) Based on the information provided in the application, candidates are provisionally invited to present themselves in person for the interview without any scrutiny of eligibility. However, on the day of interview, documents to determine eligibility w.r.t. to essential qualification(s), age, experience, as applicable, NOC etc. will be scrutinized by the Institute's scrutiny committee. Only after the satisfaction of Scrutiny Committee w.r.t his/her eligibility, a candidate will be allowed to appear in the interview for the post. Cut-off date to determine the eligibility for all purposes and in all respects is last date of filling up application form. If any ineligibility is detected at any stage, candidature of the candidate will be cancelled without any notice.
- d) Matriculation/10th Standard or equivalent certificate indicating date of birth, or mark sheet of Matriculation/10th Standard or equivalent issued by Central /State Board indicating Date of Birth should be submitted in support of claim of age.
- e) **Education Qualification certificates:** as per Recruitment Rules for the post applied must be uploaded. In case of those who have equivalent educational qualification, Order/ letter regarding equivalent Educational Qualification claimed, indicating the Authority (with number and date) under which it has been so treated, regarding equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement. The equivalent qualification will be decided by the Competent Authority of AIIMS, Jammu and his decision will be final in this regard.
- f) **Experience Certificate:** should be from the Head(s) of Organization (for the period of experience claimed, clearly showing the, duration of experience ("from" to "to"), Nature of experience (either teaching and/or research). Teaching / research experiences which are gained in organization recognized by MCI/NMC/UGC recognized teaching institutions will only be considered. Experience acquired after having acquired requisite essential qualification for the applied post will only be considered to determine eligibility as per RR for the post.
- g) **DNB equivalence:** In cases of those who are holding DNB in broad specialties or super specialty as essential qualifying education, they have to produce documentary evidence issued by Competent authority about DNB equivalence with MD/MS/DM/M.Ch as per NMC New Delhi notification dated 14.02.2022. (The Diplomat of National Board (DNB) in broad specialty and super specialty qualifications when granted in a medical institution with attached hospital or in a hospital with the strength of **five hundred or more beds**, by the National Board of Examinations, shall be equivalent in all respects to the corresponding broad specialty (MD/MS) and super specialty (DM/MCh) postgraduate qualification, but in all other cases, senior residency in a medical college for an additional period of one year shall be required for such qualification to be equivalent for the purpose of teaching.)
- h) **NOC Certificate:** No Objection Certificate from the present employer (in case of regular candidates working in Government/Semi or Quasi Government, Government enterprises or Government funded autonomous institutions) is mandatory. Those who fail to produce NOC will not be allowed to appear for the interview for the post. Therefore, candidates are advised to upload NOC along with application or alternatively must produce it at the time of interview failing which he/she shall not be interviewed. Candidates, who are working as contractual employee in Government/Semi-Government/PSUs/Autonomous Bodies or any institution funded by Government, also have to produce NOC mandatorily. - l) Applications which are not complete as required for online submission, or applications where application fee is not submitted will be rejected without any communication. Therefore, to avoid rejection of their

application, candidates are requested to make sure that application fee is paid, application is complete in all respect before they finally submit/upload the application.

- m) **PowerPoint Presentation:** Candidates are required to bring a Power Point Presentation of work/major achievements (loaded in own Pen drive containing PPT only), not exceeding five minutes covering the following aspects (05 slides only):
- First Slide: Mentioning only Name and the post applied for
 - Second slide: Educational Qualifications (including the year & name of institutes from where he/she has secured the degree).
 - Third slide: Working Experience (include the year & name of institutes where he/she has worked
 - Fourth Slide: Research/Publications
 - Fifth Slide. Major Recognition/Awards/innovations.
- n) Candidates must note that mere appearing in interview does not confer them any right to selection. Candidates have to score minimum qualifying marks in interview as may be fixed by the Selection Committee for empanelment in the order of merit for selection.
- o) **Document Verification:** All the original certificates/documents will be verified at the time of interview. The short-listed candidate(s) who are called for interview should bring print out of online application, a set of self-attested photocopy of all documents uploaded online along with Original certificates / documents. (i) 10th class, (ii) essential educational qualifications and experience certificate/s. 16. **DISQUALIFICATION FOR APPOINTMENT ON MEDICAL GROUNDS:** - Candidate shall be appointed to the

Service, only if, after such medical examination, as the Institute may prescribe, he/she is found to be in good mental or bodily health and free from any mental or physical defect likely to interfere with the discharge of the duties of the Service.

17. **ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT:** Candidates are warned that they should not furnish any particulars that are false or suppress any material information in filling up the application form and any documents in the recruitment process. Other Terms and Conditions for Professor (Consultant):

- i. The engagement of retired faculty consultant is purely on contract basis for an initial term of not exceeding one year from the date of joining duty after acceptance of contract. The term may be extended by another one year as per functional requirements of the Institute or till the attainment of age 70 years or till the post is filled by regular appointment, whichever is earliest. The period of contract is subject to be reduced or extended at the sole discretion of the Competent Authority, AIIMS Vijaypur Jammu.
- ii. The retired faculty consultant will be assigned clinical, teaching and research duties, besides any other work as deemed fit by the Director of the Institute.
- iii. The retired faculty consultant will report to the Director of the Institute.
- iv. During the period of contract, retired faculty consultant will be paid a consolidated monthly remuneration as indicated in the letter of engagement subject to satisfactory output. His remuneration shall be all inclusive and subject to deduction to tax at source and / or any other statutory deductions to the extent required under the laws.
- v. Participation of retired faculty consultant in National Seminars/ Conferences would be permissible as per entitlement of regular Faculty. In case retired faculty consultant is also deputed out of station on official assignment, TA/DA would be paid on tour, as admissible, as per entitlement against post last held immediately before retirement.
- vi. Retired Faculty Consultant will be eligible for thirty (30 days) leave in a calendar year, on cumulative basis.
- vii. During the period of contract, the engagement is liable to be terminated at any time with a one-month notice, without assigning any reason whatsoever. It will be open to the Institute to pay, in lieu of notice, salary for the period by which the notice period falls short. Similarly, the retired faculty consultant may also terminate the contract any time with one month's notice. The termination may be allowed with lesser notice period also provided the retired faculty consultant deposits with the Institute appropriate amount equivalent to the consolidated remuneration of the period by which the notice period falls short, in lieu of the notice period.
- viii. Private practice of any kind, including laboratory and consultant practice is prohibited. The retired faculty consultant will not engage himself/herself in any other paid assignment during the validity of this contract.
- ix. If at any time, in the opinion of competent authority, which is final in this matter, retired faculty consultant is found non-performing or guilty of any offence, dishonest, disobedience, disorderly behavior, negligence, indiscipline, absence from duty without permission or any other conduct considered by the competent authority, deterrent to the interest of AIIMS or violation of one or more terms and conditions of this letter, his/her services may be terminated without notice and the competent authority shall be entitled to recover any damages arising out of any act or omission on his/her part, from him/her.
- x. Other conditions of service will be as provided under the Rules, Bye laws and Regulations of the Institute and governed by the relevant rules and orders issued by the Government of India. It may please noted that the retired faculty consultant will be required to conform to the Rules, Bye laws, Regulations, Discipline and code of conduct prevailing in the Institute from time to time.
- xi. Retired Faculty Consultant will be governed, in respect of any matter relating to the conduct, discipline, in respect of which no provisions have been made in these terms and conditions, the provisions of CCS conduct Rule 1964, CCS (Pension) rules 1972 and Central Civil Services Classification Control and Appeal Rules 1965 as amended from time to time.
- xii. Retired Faculty Consultant will be at the disposal of the Institute on whole time basis and his/her services may be utilized in any manner required by the Competent Authority of the Institute without any claims for any additional remuneration.
- xiii. The Institute will not be responsible for any loss, accident, damages or injury while performing the consultancy assignment including travel.
- xiv. His/her services would be terminated, if involved in corrupt practices, besides taking action as per rules/law.
- xvi. Retired Faculty Consultant will devote his/her whole time and attention exclusively to the duties entrusted to him/her to the best of his/her power, ability and skill.
