All India Institute of Medical Sciences (AIIMS), Jammu, an Institute of National Importance, is one of the new AIIMS and apex healthcare Institute under the Pradhan Mantri Swasthya Suraksha Yojana (PMSSY) which has been established by the Ministry of Health and Family Welfare, Govt. of India, with the aim of correcting regional imbalance in quality tertiary level healthcare in the country, and attaining self-sufficiency in graduate, postgraduate and higher medical education and training.

Online applications from Indian citizens/persons registered as Overseas Citizen of India (OCI) cardholder under Section 7A of the Citizenship Act, 1955 as permissible under the applicable Act/Rules are invited for the following faculty posts on contract basis in various departments of All India Institute of Medical Sciences, Jammu.

GENERAL TERMS & CONDITIONS

- 1. The AIIMS, Vijaypur, Jammu reserves the rights to increase or decrease or not to fill up any post(s) without assigning any reason. The Competent Authority reserves the right to amend, cancel or change this advertisement as a whole or in part without assigning any reason or giving notice.
- 2. Applicants must possess the essential qualification and experience up-to-the last date of online submission of application(s). Their candidature will be cancelled at any stage if it is found that their educational qualification or experiences is/are not genuine.
- 3. **UPPER AGE LIMIT**: 50 years for Assistant Professor. For Professor (Consultant) as per Other Terms & Conditions given below.
- 4. **SELECTION PROCESS**: Selection is based on performance in the Interview. However, written test or screening, based on objective criteria may be done to short list applicants to be called for interview. The decision of the Competent Authority regarding shortlisting of candidates to be called for interview, would be final and binding on all candidates.
- 5. Canvassing of any kind will be a disqualification.
- 6. The candidate should not have been convicted by any Court of Law.
- 7. All disputes will be subject to jurisdiction of Court of Law at Jammu UT of J& K.
- 8. **APPLICATION FEE**: Rs 1000/- (Non-refundable)
- 9. **APPLICATION PROCESS:** The aspiring applicants satisfying the eligibility criteria in all respects can submit hard copy of application forms to Registrar, Academic Block, AIIMS, Vijaypur, Jammu on or before the last date as mentioned.

10. ELIGIBILITY NORMS:

- a) The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling eligibility criteria as on the closing date of Online applications i.e. should have passed qualifying exam for essential education qualification / have completed duration of experience as given in Recruitment rules on or before last date of online submission of form. In those cases where one passes exam or complete duration of experience after this date, their candidature will stand cancelled.
- b) Candidates must upload the documents/certificates in support of all the claims made by them in the application like, Date of Birth, Experience (in sequence as mentioned in application), Essential qualification(s), or any other information as applicable in their case, separately against each claim. Each document should be uploaded in PDF format. File size should not exceed the prescribed limit. Print out of all such file should be legible when printouts are taken. For this purpose, the applicant should scan the

- documents/certificates in 200 dpi grey scale. Documents which have not been asked for like Pay Slip, Resume, Appointment letter, Relieving letter, Un-signed Experience Certificate etc. <u>must not be</u> uploaded in Document upload module.
- c) Based on the information provided in the application, candidates are provisionally invited to present themselves in person for the interview without any scrutiny of eligibility. However, on the day of interview, documents to determine eligibility w.r.t. to essential qualification(s), age, experience, as applicable, NOC etc. will be scrutinized by the Institute's scrutiny committee. Only after the satisfaction of Scrutiny Committee w.r.t his/her eligibility, a candidate will be allowed to appear in the interview for the post. Cut-off date to determine the eligibility for all purposes and in all respects is last date of filling up application form. If any ineligibility is detected at any stage, candidature of the candidate will be cancelled without any notice.
- d) Matriculation/10th Standard or equivalent certificate indicating date of birth, or mark sheet of Matriculation/10th Standard or equivalent issued by Central /State Board indicating Date of Birth should be submitted in support of claim of age.
- e) Education Qualification certificates: as per Recruitment Rules for the post applied must be uploaded. In case of those who have equivalent educational qualification, Order/ letter regarding equivalent Educational Qualification claimed, indicating the Authority (with number and date) under which it has been so treated, regarding equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement. The equivalent qualification will be decided by the Competent Authority of AIIMS, Jammu and his decision will be final in this regard.
- f) Experience Certificate: should be from the Head(s) of Organization (for the period of experience claimed, clearly showing the, duration of experience ("from" to "to"), Nature of experience (either teaching and/or research). Teaching / research experiences which are gained in organization recognized by MCI/NMC/UGC recognized teaching institutions will only be considered. - NOC Certificate: No Objection Certificate from the present employer (in case of regular candidates working in Government/Semi or Quasi Government, Government enterprises or Government funded autonomous institutions) is mandatory. Those who fail to produce NOC will not be allowed to appear for the interview for the post. Other Terms and Conditions for Professor (Consultant):

- i. The engagement of retired faculty consultant is purely on contract basis for an initial term of not exceeding one year from the date of joining duty after acceptance of contract. The term may be extended by another one year as per functional requirements of the Institute or till the attainment of age 70 years or till the post is filled by regular appointment, whichever is earliest. The period of contract is subject to be reduced or extended at the sole discretion of the Competent Authority, AIIMS Vijaypur Jammu.
- ii. The retired faculty consultant will be assigned clinical, teaching and research duties, besides any other work as deemed fit by the Director of the Institute.
- iii. The retired faculty consultant will report to the Director of the Institute.
- iv. During the period of contract, retired faculty consultant will be paid a consolidated monthly remuneration as indicated in the letter of engagement subject to satisfactory output. His remuneration shall be all inclusive and subject to deduction to tax at source and / or any other statutory deductions to the extent required under the laws.
- v. Participation of retired faculty consultant in National Seminars/ Conferences would be permissible as per entitlement of regular Faculty. In case retired faculty consultant is also deputed out of station on official assignment, TA/DA would be paid on tour, as admissible, as per entitlement against post last held immediately before retirement.
- vi. Retired Faculty Consultant will be eligible for thirty (30 days) leave in a calendar year, on cumulative basis.
- vii. During the period of contract, the engagement is liable to be terminated at any time with a one-month notice, without assigning any reason whatsoever. It will be open to the Institute to pay, in lieu of notice, salary for the period by which the notice period falls short. Similarly, the retired faculty consultant may also terminate the contract any time with one month's notice. The termination may be allowed with lesser notice period also provided the retired faculty consultant deposits with the Institute appropriate amount equivalent to the consolidated remuneration of the period by which the notice period falls short, in lieu of the notice period.
- viii. Private practice of any kind, including laboratory and consultant practice is prohibited. The retired faculty consultant will not engage himself/herself in any other paid assignment during the validity of this contract.
- ix. If at any time, in the opinion of competent authority, which is final in this matter, retired faculty consultant is found non-performing or guilty of any offence, dishonest, disobedience, disorderly behavior, negligence, indiscipline, absence from duty without permission or any other conduct considered by the competent authority, deterrent to the interest of AIIMS or violation of one or more terms and conditions of this letter, his/her services may be terminated without notice and the competent authority shall be entitled to recover any damages arising out of any act or omission on his/her part, from him/her.
- x. Other conditions of service will be as provided under the Rules, Bye laws and Regulations of the Institute and governed by the relevant rules and orders issued by the Government of India. It may please noted that the retired faculty consultant will be required to conform to the Rules, Bye laws, Regulations, Discipline and code of conduct prevailing in the Institute from time to time.
- xi. - xii. Retired Faculty Consultant will be at the disposal of the Institute on whole time basis and his/her services may be utilized in any manner required by the Competent Authority of the Institute without any claims for any additional remuneration.
- xiii. The Institute will not be responsible for any loss, accident, damages or injury while performing the consultancy assignment including travel.
- xiv. Retired Faculty Consultant will not have a acquire during validity of this contract either directly or indirectly any outside interest, in any business or otherwise, which could be in conflict with the interest, of Institute as a whole or that would be prejudicial to his/her position. Retired Faculty Consultant will declare any interests in any commercial concern or companies etc. before joining. Failure to do so will entail termination of his/her contract forthwith without prejudice to the right of this Institute for initiation of legal action against him/her as deemed fit.

- xv. Retired Faculty Consultant and his/her family members shall not accept any gifts or presentations, directly or indirectly, whether in the form of money, fee possession of goods or other benefits from any person or firm with whom he/she or is likely to have dealing. His/her services would be terminated, if involved in corrupt practices, besides taking action as per rules/law.
- xvi. Retired Faculty Consultant will devote his/her whole time and attention exclusively to the duties entrusted to him/her to the best of his/her power, ability and skill. He/she will acknowledge that his/her position entails absolute confidentiality and therefore during the continuance of this contract/arrangement and /or after cessation of this contract for any reasons Whatsoever, he/she will not indulge or disclose any information papers and documents in his/her knowledge and custody to any outsider and maintain confidentially.
- xvii. Retired Faculty Consultant is liable to make good any of loss sustained by the Government due to his/her misbehavior or negligence.
- xviii. Retired Faculty Consultant will not engage himself/herself in any other paid assignment during the validity of this contract.
- xix. Retired Faculty Consultant will not disclose or divulge or make public or shall personally use for any gain any of the materials, processes, accounts, transactions, dealings, information etc. whether the same way be confined to him/her or may become known to him/her during the course of his/her service or otherwise.
- xx. In case Retired Faculty Consultant is employed elsewhere, he/she will bring a letter from his/her present employer stating that his/her resignation has been accepted and he/she is relieved.
- xxi. In case any of the above conditions are violated, the appointment shall automatically stand cancelled.
- xxii. Upon termination for whatever reasons, Retired Faculty Consultant will forthwith return to Institute all records/documents and papers that are in his/her custody and control, by virtue of his/her engagement and obtain discharge in writing from Institute.
- xxiii. Retired Faculty Consultant will not seek or try to secure any other job or employment without previous written sanction/consent of the Institute.
- xxiv. There will be periodical monitoring of the performance of the contractual appointee and in the event that his/her performance is found to be unsatisfactory, his/her contract is liable to be terminated and/or his/her payments withheld till satisfactory progress is achieved by him/her.
- xxv. The contract shall be governed by the rules, regulation and law of the Government of India.
- xxvi. In the event of any conflict regarding terms of appointment, the decision of the Institute shall be final.
